



Mapping of PHAOD Episode Fields to AODTS NMDS Episode Fields

Introduction

This document outlines the mapping of fields from the Primary Health Alcohol and Other Drug Dataset (PHAOD) Episode data to the Alcohol and Other Drug Treatment Services National Minimum Data Set (AODTS NMDS) Episode data. This document is intended to provide guidance to data users on how to map the fields between the PHAOD and AODTS NMDS datasets. It is important to note that the fields in the clinical tool and service contact table from the PHAOD data specification are not available in the AODTS NMDS.
