Mental Health Priority Area 2: Child and youth mental health services

Aim of Activity

The aim of the headspace activity is to provide young people, aged 12-25 years, with access to a suite of integrated, culturally appropriate services to holistically address their mental health and wellbeing. The headspace Enhancement funding will be used to build the cultural capability of the Broome headspace service to improve access and provide better support for young Aboriginal people.

Description of Activity

The headspace enhancement funding is being utilised to expand the headspace service's capacity to respond to local need, within the parameters of the headspace Model Integrity Framework.

The headspace Broome will utilise the funds to recruit, employ and train a female Aboriginal Social and Emotional Wellbeing worker position (1.0 FTE); and to undertake targeted community engagement and awareness activities which encourage early help seeking, reduce stigma, and increase mental health literacy.

Aim of Activity

The aim of the headspace activity is to provide young people, aged 12-25 years, with access to a suite of integrated, culturally appropriate services to holistically address their mental health and wellbeing. The headspace Enhancement funding will be used to modernise and improve headspace premises and build service capacity.

Description of Activity

The headspace enhancement funding is being utilised to expand the headspace service's capacity to respond to local need, within the parameters of the headspace Model Integrity Framework.

headspace Broome will utilise the funds to:

- soundproof additional consult rooms.
- utilise 2 x consult rooms in the adjacent building.

This capital work will enable more young people to receive a service, including specialist services (in-reach psychiatry, ADHD Psychiatry, family & peer support and AOD counselling).

headspace Hedland will utilise the funds to:

- repair/replace 10 air conditioning units.
- deliver increased client activities, provide increased opportunities for Aboriginal organisations and partner agencies to operate from the space, and provide more opportunities for young people to use the building for YAG meetings and other activities.





- improve safety and security-related maintenance upgrades, including ensuring all externally facing doors close and lock correctly.
- install additional connection points throughout the headspace Hedland building.
- increase the accessibility of the service by providing the ability for young people to charge their devices and access hot desks through which to complete homework, job applications and training.

This work will increase the capacity of the headspace service to deliver appropriate, safe and accessible services for the Pilbara community.

Aim of Activity

The aim of this Capital Works Agreement for headspace Centre Expansion is to enhance the quality of experience for young people aged 12 to 25 years in accessing mental health services provided through headspace Albany.

The aim of the activity will be to enhance the quality of experience for young people aged 12 to 25 years in accessing mental health services provided through headspace Centres.

Description of Activity

This activity will increase the efficiency and effectiveness of primary mental health services at the Geraldton and Bunbury headspace sites.

Geraldton headspace walk in clinic will be supported with:

- Recruiting staff to introduce a single session stream
- Maintaining clinical staffing funded through previous demand management funding
- Undertaking workforce engagement and training

Capital works activity will fit out a new Bunbury headspace site that will improve access for young people in the Bunbury region, to a fit for purpose and engaging environment. The relocation of the Bunbury headspace service has been completed in this reporting period with the service now operating from the new premises. The new premises provide a safe and welcoming environment purpose built for the delivery of headspace services.

The Albany headspace Centre fit out was completed during the previous reporting period. The additional counselling rooms, flexible meeting and group spaces, and expanded working areas have improved access to mental health services for youth in the Great Southern.
