## Benefits of access to up-to-date important health information via My Health Record

- Informed decision-making
- Minimised test duplication

- Improved continuity of care
- Lower risk of adverse events
- Reduced clinician admin burden and increased efficiency

## **Uploading Considerations**

Documents uploaded by GPs, RN's and NPs to My Health Record can be viewed by the patient and other healthcare providers involved in their care. Other clinicians accessing My Health Record may include pharmacists, hospital physicians and emergency teams, specialists, residential and community aged care nurses, and allied health clinicians. This information may include medical history, medicines history, allergies, immunisation records, MBS and PBS items
